		 TVOC emission detectors are provided in appropriate locations to monitor and control fugitive emission. In the existing unit, District Environment Laboratory (DEL)-Manali of TNPCB is carrying out the TVOC survey every year and the same will be continued after expansion. Continuous AAQ monitoring station kept in place to monitor PM₂₅, PM₁₀ and online connected to TNPCB - CAC. The Plant is operated through DCS and the same is monitored continuously. Emission control measures will be ensured in the expansion facility also.




